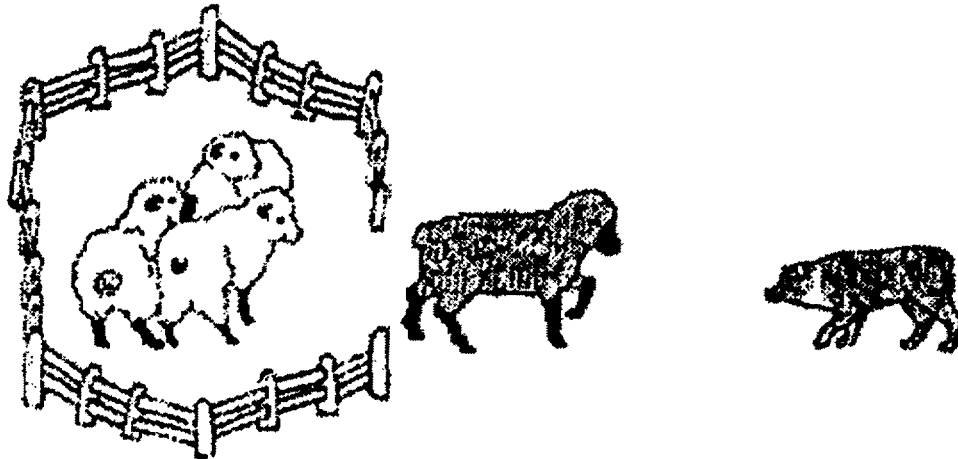

Stockdog Trial Policies:

This show is ASCA sanctioned by Black Sheep ASC. All ASCA rules apply. Black Sheep ASC and their members assume no responsibility for any loss, damage, or injury sustained by an exhibitor, handler, dog, property, child or spectator. No entry fee will be refunded if the show cannot open or be completed due to riots, civil disturbances, acts of God, public emergencies or other events beyond the control of Black Sheep ASC. An official waiting list will be maintained. Random draw for run order will be made prior to the trial. If an owner pulls an entry, refunds will be made only if that space can be filled from the wait list. Refunds must be requested prior to the start of the trial. Bitches in season will run in draw order. Bitches in season will remain crated when not competing. All dogs must be on leash or crated when not competing. Please clean up after your dogs.

DIVISIONS: Advanced, Open, Started, Novice, Junior, FEO

DAILY PRIZES: Green ribbons will be given for qualifying scores and ribbons will be given for places 1-4 in each class. Prizes for High Score Ducks, Sheep, and Cattle per trial.

WEEKEND PRIZES: 5 Buckles will be offered for the weekend 3-day (5 trial) combined scores as follows: WTCH Aussie, High Combined Other Breed, Non-WTCH Aussie, Most Promising Started Aussie and Other Breed. To be eligible there must be at least 2 dogs entered in each class and the dog must be entered all throughout the weekend. Other special awards may be given.
